## Conroe Yacht Club Summer Invitational Regatta

**EVENT:** A one day, four race invitational event to be held June 19, 2010. The Regatta will be conducted by the Conroe Yacht Club and held on Lake Conroe, Texas.

**RULES:** The regatta will be governed by the 2009-2012 Racing Rules of Sailing (RRS), as published by US Sailing.

**PRE-REGISTRATION:** Boats will be considered pre-registered if the attached entry form is received by Saturday, June 12. Registrations will be accepted Saturday morning prior to the skippers' meeting. **This event is subject to cancellation if a minimum of five boats have not pre-registered.**

**CLASSES:** Classes will be based on pre-registered entries. Minimum one design fleet size is three boats. All other boats will be placed in handicap classes based on performance criteria and handicap rating systems. All handicap classes will use the CYC PHRF System.

**AWARDS:** All awards will be based on pre-registered entries. Three entrants, one award, and one award for each additional two entries. Maximum five awards per class.

**FACILITIES:** Launching ramps, mast stepper, slips, and storage area.
